The Barclays renews TV preview show for 2008

The Barclays tournament officials announced the renewal of the television preview show, “The Road to The Barclays” for 2008. The show will run 10 weeks from June 13 to the start of the tournament week on August 17. Each show will air multiple times each week on the MSG and MSG+ Networks and reach up to 9 million homes throughout the New York Metropolitan Area.

“The Road to The Barclays” will be a 30-minute show featuring highlights from the previous week’s PGA TOUR event, TOUR news and updates on the FedExCup Point Standings. PGA TOUR star and Barclays endorser, Phil Mickelson will make several appearances offering insights into the tournament’s new host course at The Ridgewood Country Club and professionals from Met Area golf clubs will provide instruction tips and shot demonstrations each week. The show will also feature a look at the latest innovations in golf equipment and teaching tools, a celebrity challenge featuring athletes and figures from the world of sports and entertainment and the opportunity for viewers to win tickets to The Barclays.

The show will once again be produced by Globecast Media, Inc. and hosted by five-time Emmy Award winning announcer Mike Crispino, currently one of the TV/radio voices of the New York Knicks and Rangers.

The Barclays will be held August 19-24 at The Ridgewood Country Club in Paramus, New Jersey, and is the first of four tournaments in the PGA TOUR Playoffs for the FedExCup. A top-ranked field is expected at The Barclays as players set their sights on winning the FedExCup and the \$10 million prize.
